- 1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.
- 2. **QUALIFICATIONS:** (In addition to below, see application procedures).
- a. **SPECIFIC:** Proficient in the use of Microsoft Office. Proficient in inventory and restocking supplies/equipment. High School Diploma or equivalent required.
- b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC). Ability to work and communicate effectively with peers, superiors and subordinates. Travel may be required. Must be available to report to duty during emergency or disaster situations.
- c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Ability to work and communicate effectively with agency personnel and the public. Must attend/complete all mandatory LMD training (Ethics, SHARP, Suicide Prevention, etc.) and fosters sexual harassment free environment.

- 4. **POSITION DESCRIPTION:** Supervises section in the absence of Logistics Supervisor. Represents the section at the weekly Staff Meeting in the absence of the Logistics Supervisor. Stocks shelves upon receipt of clothing; issues clothing and equipment to Cadets; and maintains Cadet clothing/equipment records. Physically receives supplies from consolidated delivery point; inventories supplies upon receipt; stocks shelves once supplies are inventoried; maintains padlock roster by serial number with combinations; performs trouser turn-in for Cadet laundry three times a week; and performs linen exchange for Cadets once a week. Must attend/complete all mandatory LMD Training (Ethics, SHARP, Suicide Prevention, etc.) and foster a sexual harassment free environment. Perform other duties as assigned.
