- 1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.
- 2. **QUALIFICATIONS:** (In addition to below, see application procedures).
- a. **SPECIFIC:** Work Schedule is weekends only (0700-1730). Must be able to work well with Military and Civilian customers. Must be able to operate Microsoft Office Programs (Word, Excel, Powerpoint, Outlook, etc.) and other office equipment. Must have the ability to operate a multi-line phone system while navigating Microsoft Office Programs. Must have excellent written and oral communication.
- b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC) Card. Travel may be required. Must be available to report to duty during emergency or disaster situations. Must have the ability to work and communicate effectively with agency personnel, peers, superiors, subordinates and the public.
- c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Must attend/complete all LMD annual training and other training required for the position. Must adhere to the Code of Ethics and foster a Sexual Harassment-Free Environment.

- b. The successful applicant will be required to join the Louisiana State Guard as a condition of employment. Service in the Louisiana State Guard does not require the applicant to perform military training, periodic inactive duty (monthly drills), nor does it require deployment outside of the State of Louisiana. The applicant can expect that service in the Louisiana State Guard to be substantially the same as normal State Government working conditions.
- 4. **POSITION DESCRIPTION:** Accept and route calls for Camp Beauregard and Jackson Barracks, as well as overflow calls for Gillis W. Long. Answer general inquiries and transfer calls to appropriate individual/section. Operate multi-line phone system prioritizing calls as they come in. Uphold policies set regarding switchboard transferring capabilities. Exercise judgement in directing calls/inquiries. Ensure familiarization with current personnel roster and organizations in order to ensure proper routing of calls. Notify the JOC Message Center when stepping away from your desk. Forward after hours calls for TAG/Command Group to the JOC Message Center. Perform general filing and administrative duties. Perform other duties as assigned.
