1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.

2. **QUALIFICATIONS:** (In addition to below, see application procedures).

a. **SPECIFIC:** Must possess knowledge and understanding in the carpentry/painting fields and in the maintenance of all carpentry shop equipment. Skilled in performing building painting work both interior and exterior. Ability to mix paint to get desired colors. Must have the ability to work independently with general guidance to meet objectives.

b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC) Card. Travel may be required. Must be available to report to duty during emergency or disaster situations. Must have the ability to work and communicate effectively with agency personnel, peers, superiors, subordinates and the public.

c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Must attend/complete all LMD annual training and other training required for the position. Must adhere to the Code of Ethics and foster a Sexual Harassment-Free Environment.

3. **CONDITIONS OF EMPLOYMENT:** By submitting an application for employment with the Military Department, the applicant agrees to the following conditions of employment:

a. Salary is paid by Electronic Funds Transfer (EFT) / Direct Deposit Only. A checking or savings account is required for employment.

b. The successful applicant will be required to join the Louisiana State Guard as a condition of employment. Service in the Louisiana State Guard does not require the applicant to perform military training, periodic inactive duty (monthly drills), nor does it require deployment outside of the State of Louisiana. The applicant can expect that service in the Louisiana State Guard to be substantially the same as normal State Government working conditions.

4. **POSITION DESCRIPTION:** Perform journeyman carpentry work under the general supervision of the Carpenter Foreman. Serves as a Painter under the immediate supervision of Painter Foreman. Construct, repair, and modification of various wooden products and wood substitutes, venetian blinds and shades, broken window panes, window sills, screen doors, windows, towel racks that racks, rocking chairs and various pieces of furniture. Adjust and/or replace doors. Build shelves in closets, tables, stand, etc. Sands, finish, refinish varnished and stained furniture and other finished articles of wood. Receive work orders and oral instructions that indicate the surfaces to be coated and the coating materials to be used. Prepare surfaces by methods such as sanding, wire brushing and pressure washing. Then, stir and mix coating material according to specific directions. Apply various coating requirements. Perform minor plastering, puttying, caulking and spackling or new or repaired work and also apply finished covering to wall surface. Perform the finishing on the sheet rock in preparation for painting. Complies with OSHA and other safety requirements Drives trucks up to two tons and forklifts in performance of duties. Assist in other crafts outside the scope of his regular duties. Must maintain and wear all safety related equipment and/or report any violations or deficiencies. Must use energy conservation measures and ensure that these measures are taken daily before leaving the job side. Maintain accountability of all equipment and/or ensure data cards are up to date. Maintain and practice good environmental protection measures. Must respond to tenant requests with professionalism and courtesy. Must inform the supervisor of all telephone and address changes. Perform other duties as assigned.
