- 1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.
- 2. **QUALIFICATIONS:** (In addition to below, see application procedures).
- a. **SPECIFIC:** Must have knowledge of Microsoft Office (Outlook, Word, Excel, Powerpoint, etc.). Must be able to operate standard office machines.
- b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC) Card. Travel may be required. Must be available to report to duty during emergency or disaster situations. Must have the ability to work and communicate effectively with agency personnel, peers, superiors, subordinates and the public.
- c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Must attend/complete all LMD annual training and other training required for the position. Must adhere to the Code of Ethics and foster a Sexual Harassment-Free Environment.

- b. The successful applicant will be required to join the Louisiana State Guard as a condition of employment. Service in the Louisiana State Guard does not require the applicant to perform military training, periodic inactive duty (monthly drills), nor does it require deployment outside of the State of Louisiana. The applicant

can expect that service in the Louisiana State Guard to be substantially the same as normal State Government working conditions.

- 4. **POSITION DESCRIPTION:** Prepares correspondence, memos and reports for Recruiter. Covers phone lines and directs visitors, trainees and mentors to appropriate staff. Assures all documents are assessable and accounted for in Trainee Folders. Assists with mentor trainings, in-processing, graduation and other Recruitment activities. Checks and distributes mail and messages. Assists other departments and performs additional duties as needed. Is the frontline for communication and reception for the Recruitment Department. Performs advanced administrative/secretarial work for Program Director in the absence of the Director's Administrative Assistant. Prepare and coordinate mail, faxes and express packages. Advise supervisor of any issues to ensure excellent customer service. File Recruitment documents as prescribed by your Recruitment Supervisor. Apply computer and related technologies to support the Recruitment staff. Prepares and maintains telephone directory for the Recruiter. Maintain supply inventory by checking stock to determine inventory level; anticipate needed supplies; place orders for supplies, verifies receipt of supplies. Occasional travel by conventional means including motor vehicle and the like within the region and to other locations as required. Enter all data for the JCP Recruitment Officer. Perform other duties as assigned.
