1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.

2. **QUALIFICATIONS:** (In addition to below, see application procedures).

a. **SPECIFIC:** Possess master knowledge and understanding in the HVAC, Electrical and Plumbing Fields. Ability to organize and prioritize work orders for short range and long range planning requirements. Possess solid knowledge in the maintenance of all HVAC, Electrical and Plumbing shop equipment. Operate computer with MS Windows operating system and Microsoft Office software. Be proficient using and maintaining all shop equipment. Work with minimal guidance, instruction or supervision.

b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC) Card. Travel may be required. Must be available to report to duty during emergency or disaster situations. Must have the ability to work and communicate effectively with agency personnel, peers, superiors, subordinates and the public.

c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Must attend/complete all LMD annual training and other training required for the position. Must adhere to the Code of Ethics and foster a Sexual Harassment-Free Environment.

3. **CONDITIONS OF EMPLOYMENT:** By submitting an application for employment with the Military Department, the applicant agrees to the following conditions of employment:

a. Salary is paid by Electronic Funds Transfer (EFT) / Direct Deposit Only. A checking or savings account is required for employment.

b. The successful applicant will be required to join the Louisiana State Guard as a condition of employment. Service in the Louisiana State Guard does not require the applicant to perform military training, periodic inactive duty (monthly drills), nor does it require deployment outside of the State of Louisiana. The applicant can expect that service in the Louisiana State Guard to be substantially the same as normal State Government working conditions.

4. **POSITION DESCRIPTION:** Execute routine, preventative and emergency HVAC, Electrical and Plumbing work orders. Grasp organizational policies, standard operating procedures and facility layout. Perform journeyman level work in HVAC, Electrical and Plumbing tasks. Maintain and update the FE work order system on HVAC, Electrical, and Plumbing related items. Develop bills of materials for electrical work packages, work orders and projects. Read and interpret blueprints, schematics and shop drawings for construction and fabrication projects. Procure parts and materials within established guidelines. Control, secure, inventory and dispatch tools, materials and equipment. Assist with HVAC, Electrical and Plumbing related contractual services/projects and/or annual military training projects. Coordinate maintenance of electrical distribution systems with the local utility company. Demonstrate strong communication skills interacting with organizational personnel, tenants and contractors. Assist FE team members in trouble shooting and repairs of plumbing and electrical systems. Attend schools, classes, seminars and meetings as required. Perform other duties as assigned.

5.
