1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.

2. QUALIFICATIONS: (In addition to below, see application procedures).

a. **SPECIFIC:** Proficient in the use of Microsoft Office. Proficient in inventory and restocking supplies/equipment. High School Diploma or equivalent required.

b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC) Card. Travel may be required. Must be available to report to duty during emergency or disaster situations. Must have the ability to work and communicate effectively with agency personnel, peers, superiors, subordinates and the public.

c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Must attend/complete all LMD annual training and other training required for the position. The applicant can expect that service in the Louisiana State Guard to be substantially the same as normal State Government working conditions.

4. **POSITION DESCRIPTION:** Stocks shelves upon receipt of clothing. Measures cadets for clothing. Issues clothing and equipment to cadets. Maintains cadet clothing/equipment records. Physically receives supplies from consolidated delivery point. Inventories supplies upon receipt. Stocks shelves once supplies are inventoried. Maintains padlock roster by serial number with combinations. Performs trouser turn-in for cadet laundry three times a week. Performs linen exchange for cadets once a week. Perform other duties as assigned.
