EMPLOYEES IN THE MILITARY DEPARTMENT UNCLASSIFIED SERVICE, PERMANENT OR TEMPORARY, ARE EMPLOYED "AT WILL" AND MAY BE SUBJECT TO TERMINATION OR EXPIRATION OF APPOINTMENT, WITH OR WITHOUT CAUSE.

1. **AREA OF CONSIDERATION:** (1) Active Louisiana National Guard Members; (2) Retired National Guard Members and Retired Military Members; (3) those eligible for Louisiana State Guard Membership.

2. **QUALIFICATIONS:** (In addition to below, see application procedures).

a. **SPECIFIC:** Proficient in Microsoft Word and Outlook. Proficient in the use of various hand and power tools as well as assorted multi-meters, etc. Basic plumbing, electrical and carpentry skills

b. **GENERAL:** Must have a valid Driver's License, Social Security Card and Birth Certificate. Must qualify to obtain a Common Access Card (CAC) Card. Travel may be required. Must be available to report to duty during emergency or disaster situations. Must have the ability to work and communicate effectively with agency personnel, peers, superiors, subordinates and the public.

c. **OTHER REQUIREMENTS:** The LA Military Department is a substance abuse and drug free workplace. In accordance with the Military Department Drug Testing Policy, all new employees are subject to mandatory drug testing. Thereafter, all employees are subject to random drug testing. Must meet physical requirements to perform functions of the position. Must attend/complete all LMD annual training and other training required for the position. Must adhere to the Code of Ethics and foster a Sexual Harassment-Free Environment.

3. **CONDITIONS OF EMPLOYMENT:** By submitting an application for employment with the Military Department, the applicant agrees to the following conditions of employment:

a. Salary is paid by Electronic Funds Transfer (EFT) / Direct Deposit Only. A checking or savings account is required for employment.

b. The successful applicant will be required to join the Louisiana State Guard as a condition of employment. Service in the Louisiana State Guard does not require the applicant to perform military training, periodic inactive duty (monthly drills), nor does it require deployment outside of the State of Louisiana. The applicant can expect that service in the Louisiana State Guard to be substantially the same as normal State Government working conditions.

4. **POSITION DESCRIPTION:** Assists the Maintenance Supervisor in maintaining Work Order Log. Delivers work orders to Facility Engineers. Coordinates with Facility Engineers for assistance with projects in the absence of the Maintenance Supervisor. Assists the Maintenance Supervisor troubleshooting, assembling required materials for and repairing routine plumbing failures. Assists the Maintenance Supervisor troubleshooting, assembling required materials for and repairing routine electrical failures. Replaces light bulbs and fixtures in YCP buildings and hallways as required. Replaces damaged HVAC return vents, FRP panels and other carpentry work in the barracks as required. Assists the Maintenance Supervisor in maintaining 12 golf carts. Assists the Maintenance Supervisor in maintaining various pieces of DFAC equipment. Assists the Maintenance Supervisor in maintaining 16 washers and 16 dryers in YCP barracks. Installs floor tiles in barracks as required. Preps surfaces and paints projects requiring paint. Assists in supply functions such as clothing measurement, clothing issue, trouser tum-in for laundry and linen exchange when requested. Performs other duties as assigned.

5. **APPLICATION PROCEDURES:** All Applicants must complete a LANG-LMD-H Form 10 (State Application) and attach a legible copy of their Official Birth Certificate, Driver's License and Social Security Card.
