NO EXCEPTIONS: Soldiers without a qualified MOS/AOC or who are SMP are not authorized to be in a FTNGD-OS status.

DA Form 4187 - Submit 4187 electronically (not scanned as a pdf). Route packet thru BN to DRU and Hiring Agency; Hiring Agency submits to AGR Branch (ng.la.laarnng.list.ftngdos-long-tour@mail.mil) for certification; AGR Branch to Hiring Agency or J3 for orders production.

DA Form 1058 – Dated within two months of the start date.

DA Form 4856 - Counseling statement including: commuting distance, statement of current health, GVCC, leave management, TDY travel and the temporary nature of FTNGD-OS tours.

DA Form 5960 - With support documents (marriage/divorce, birth, child custody, etc.). CMDR/Soldier signed within two months of the start date. The CMDR/SM **DO NOT** need to sign on the same date, wet or digital.

NGB 23 (A or B) – Generated within two months of the start date.

DA 705 – Current guidance: APFT or ACFT with a no earlier than (NET) date of 01March2019. **HT/WT Memo for all and DA Form 5500/5501 if applicable** – Generated within six months of start date.

MEDPROS Individual Medical Report (IMR) – Must be MRC1 or MRC2, HIV within two years and PHA within one year of the start date. **DA 3349**, if applicable, temporary profiles require an ETP.

DD Form 93 – Valid within one year of the start date.

Pregnancy test results – All female Soldiers, within 30 days of the start date. A pregnancy test result is **NOT** required for rollover packets.

Current Federal Technicians – If applicable, exception to policy (ETP) memo completed.

Other ETPs – If applicable, are included in the application packet for any deficiency. Ensure ETPs have appropriate endorsements IAW FTNGD-OS ETP Request Memo. ETPs are approved on a case by case basis. Anticipate ETP approval adding an additional four working days to the approval process.

Unit has verified: Enlisted Soldiers will have at least one year of service remaining on their contract from the start date. If the extension is has not processed units must include a copy of the completed DA 4836 with the packet. Soldier does not have pay orders (IDT, schools, ect) pending that will conflict with entry into a FTNGD-OS status. Soldier is not flagged.

Unit has verified cont: The FTNGD-OS tour will not cause the member to exceed 2190 days (6yrs) of continuous active duty or 17 years of total active federal service.
