Eligibility for Camp Minden Lottery Application:

Authorized applicants must be a Louisiana National Guard or Louisiana Military Department employee or retired from one of the above. Applicants must submit a 20-year letter, a NGB Form 22, a DD214, or retirement orders.

Louisiana National Guard Soldiers and Airmen must provide a letter of good standing from their unit with a contact name and phone number of their commander or authorized unit representative.

LMD employees must provide a signed letter from their direct supervisor, which states they are in good standing and a valid member of the LMD.

- 1.1. Louisiana National Guard (Airforce and Army): LANG personnel may participate in hunting activities on Camp Minden. LANG members will be responsible for obtaining a letter from his or her unit, signed by the commander or his or her designee, which states that they are in good standing with the LAANG. The letter must include a contact number for verification purposes.**
- 1.2. Louisiana Military Department (LMD): LMD personnel may participate in hunting activities on Camp Minden. LMD personnel will be responsible for obtaining a letter signed by his or her direct supervisor, which states that they are a valid member of the LMD in good standing with the LMD. The letter will include a contact number for verification purposes.**
- 1.3. Retired LANG Members: Retired LANG members will be responsible for providing a copy of his or her 20-year letter, a copy of his or her NGB Form 22, a DD 214, or retirement orders.**

All persons must provide a valid hunter education certificate and number.

Applicants must remove all hunting gear to be eligible for the 2024-2025 lottery.

CAMP MINDEN HUNTING LOTTERY

NOTICE: Camp Minden Hunting Lottery Fees

Applications are being accepted for the 2024-2025 Camp Minden Hunting Season.

Primary: Only currently serving or retired Louisiana National Guardsmen, employees of the Louisiana National Guard, and currently serving or retired employees of the Louisiana Military Department can apply.

Guest: *One guest of primary hunter's choice*. Only one person may hunt with Primary at a time.

(*A primary hunter may not sponsor a Louisiana National Guardsman or LMD Employee or a retired member of either, they must be registered as a primary hunter during the lottery period*).

Applications can be found on the J6 Bulletin Board. All applications for Lottery selection must be emailed to the Louisiana Military Department Wildlife Office ng.la.laarnng.mbx.cm-hunting@army.mil NLT **15 June 2024**.

If you do not receive a confirmation email, it is your responsibility to contact the LMD Wildlife Office to make sure that your application was received. Selected applicants must attend a mandatory Camp Minden Hunting meeting on posted locations and dates to complete a Camp Minden Hunter registration form and pay applicable fees.

If you do not attend one of the mandatory meetings, you will not be allowed to hunt during the 2024-2025 deer season.
