WHO MAY APPLY:

Must be a current member of the LA National Guard within the grade(s) of E5 and E6.

AREA OF CONSIDERATION: This position is open to the grades of: E5 to E6. Individual selected will receive an AGR Tour with the Louisiana National Guard. In order to be considered for this position's applicants must meet minimum qualifications as outlined on this announcement.

INSTRUCTIONS FOR APPLYING: All documents will be uploaded to FTSMCS no later than 2300 as one PDF in the order listed on the checklist. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position by the hiring agency.**

1. AGR APPLICATION

MINIMUM APPOINTMENT REQUIREMENTS:

All enlisted jobs will be staffed in accordance with LAARNG AGR Enlisted Career Management Policy dated 1 December 2023.

1. Must be able to attain SQI 8 within the first 3 months.
2. Valid state operator's license. Valid military operator's license.
3. Must be an E5 or above, 88M MOSQ and on the EPS OML
4. Soldier must be able to push/pull (on wheels) up to 100 pounds (General Mechanic's Tool Kit) up to 25 feet individually and lift/lower 100 pounds 4 feet then carry 25 feet as part of a two Soldier team (prorated 50 pounds per Soldier) while wearing/carrying 80 pounds of uniform and combat equipment.

ADDITIONAL JOB INFORMATION:

- All exception to Policy request must be processed through Chain of Command and submitted with your AGR application to the AGR Branch regardless of concurrence.
- LAARNG promotion policies apply together with maximum grade limitations for the position as designated by NGB and appropriate MTOE/TDA.
- Acceptance of tour is subject to personal interview, ACFT, and Army body fat standards upon notification of time and place. Necessary travel is at applicant's own expense.
- AGR applicants must hold a SECRET security Clearance.
- Initial hire applicants must be able to obtain SECRET security Clearance
- Any Soldier selected without having a valid security clearance will be placed on OTOT (One Time Occasional Tour) and will be afforded an opportunity to attain appropriate clearance required. Soldier will be terminated upon receiving notification of his/her inability to acquire mandatory clearance for AGR Full-Time Position.
- Direct combat probability code applies: No, male or female may apply
- Deployed Soldiers are encouraged to apply for jobs. Deployment will not be held against the Soldier during the hiring process.
- NON-AGR applicants who require civil conviction waivers (applicants who possess civil convictions) must have approved waiver requests prior to closing of the AGR Tour Announcement that the Soldier is applying for. Any pending convictions should be annotated on the NGB 34-1 in Section V. Omitting any pertinent information that could effect becoming fully qualified is grounds for termination.
- NON-AGR Soldiers must meet eligibility requirements and qualifications for initial entry (3 year) in the AGR program IAW AR 135-18, Table 2-1 and NGR 600-5, Chapter 2-2. Applicants must be medically and physically qualified for Active Duty IAW AR 40-501, Chapter 3 and AR 600-9
- NON-AGR Soldiers must be able to complete their initial tour prior to reaching 18 years Active Federal Service or Retention Control Point.
- Acceptance to a position of higher grade, SM will incur a service obligation in accordance with AR 600-8-19 upon promotion.
- Acceptance of this position may result in the loss of contracted incentive payments based on CURRENT incentive contract. For further details, contact the State Incentive Management Team at (504) 278-8116 or (504) 278-8255.

BRIEF JOB DESCRIPTION:

Serves as a RTI Instructor; uses approved TRADOC programs of instruction (POI) providing technical training and guidance for AC, USAR and ARNG Soldiers; Manage the class and maintain an environment conducive to learning. Supervise and guide the learning process, assess the performance of each student, obtain immediate feedback on student performance, and apply remedial training as required. The course standardization section will administer tests and accurately enter results on appropriate forms and records. Coordinate and properly use and maintain material and equipment. Provide timely input to the course chief prior to issuing certificates of training according to FORSCOM/TRADOC Reg. 135-3. Continuously evaluate course effectiveness and provide data and any requirements for course change to the course chief or course manager. Ensure students comply with safety and environmental protection rules, regulations, laws, and course requirements. Explain the graduation criteria and requirements to the students prior to start of training. Ensure ISAP is posted in classroom and provided to students. Counsel

students. Provide appropriate remedial training. Continuously evaluate course effectiveness and efficiency and provide appropriate feedback to the training/training development (task) proponent; maintains, assists in the revision of, and updates to course material; conducts remedial training, examinations, and evaluations; provides mentorship, supervision and the responsibility of the health and welfare of Soldiers; ensures accountability and positive control of test materials protecting the integrity of examinations; serves as a SME for certification boards; maintains accountability of computers, tools,
