#### MINIMUM APPOINTMENT REQUIREMENTS:

All enlisted jobs will be staffed in accordance with LAARNG AGR Enlisted Career Management Policy dated 1 December 2023.

- 1. Applicant must hold or be able to obtain the 68W2O MOS within one year of initial hire. Non MOSQ Soldiers must possess an aptitude ST and GT score as follows: ST score of 105 and GT score of 110 with test date prior to 2 January 2002, ST score of 102 and GT score of 110 on or after 2 January 2002 and prior to 1 July 2004, ST score of 101 and GT score of 107 on and after 1 July 2004.
- 2. Applicant must meet the following physical profile requirements in order to qualify for 68W MOS: 1. A physical demands rating of moderately heavy, 2. A physical profile of 111121, and 3. No aversion to blood.

#### ADDITIONAL JOB INFORMATION:

- All exception to Policy request must be processed through Chain of Command and submitted with your AGR application to the AGR Branch regardless of
  concurrence.
- LAARNG promotion policies apply together with maximum grade limitations for the position as designated by NGB and appropriate MTOE/TDA.
- Acceptance of tour is subject to personal interview, ACFT, and Army body fat standards upon notification of time and place. Necessary travel is at applicant's own expense.
- AGR applicants must hold a SECRET security Clearance.
- Initial hire applicants must be able to obtain SECRET security Clearance
- Any Soldier selected without having a valid security clearance will be placed on OTOT (One Time Occasional Tour) and will be afforded an opportunity to
  attain appropriate clearance required. Soldier will be terminated upon receiving notification of his/her inability to acquire mandatory clearance for AGR Full-Time
  Position
- Direct combat probability code applies: No, male or female may apply
- Deployed Soldiers are encouraged to apply for jobs. Deployment will not be held against the Soldier during the hiring process.
- NON-AGR applicants who require civil conviction waivers (applicants who possess civil convictions) must have approved waiver requests prior to closing of
  the AGR Tour Announcement that the Soldier is applying for. Any pending convictions should be annotated on the NGB 34-1 in Section V. Omitting any
  pertinent information that could effect becoming fully qualified is grounds for termination.
- NON-AGR Soldiers must meet eligibility requirements and qualifications for initial entry (3 year) in the AGR program IAW AR 135-18, Table 2-1 and NGR 600-5, Chapter 2-2. Applicants must be medically and physically qualified for Active Duty IAW AR 40-501, Chapter 3 and AR 600-9
- NON-AGR Soldiers must be able to complete their initial tour prior to reaching 18 years Active Federal Service or Retention Control Point.
- Acceptance to a position of higher grade, SM will incur a service obligation in accordance with AR 600-8-19 upon promotion.

## **BRIEF JOB DESCRIPTION:**

1. DUTIES AND RESPONSIBILITIES: Administers emergency treatment in the field; assists with outpatient and inpatient care; maintains health records and clinical files; assists with nursing care of patients including medical examinations; takes and records temperature, pulse, respiration, and blood pressure; applies and removes surgical, wound, or skin dressings; collects and prepares specimens for analysis; assists in clinic and dispensary; performs routine admission tests; administers immunizations; assists with treatment of patients with common diseases; provides emergency medical care; surveys and sorts casualties; determines requirements for and administers emergency treatment; assists with triage of mass casualties; performs duties related to emergency care. Administers emergency and routine medical treatment to casualties, including minor surgery and iv fluid administration; assists with outpatient care and supervises outpatient facilities under the supervision of a physician, nurse, or physician's assistant; establishes priorities for medical emergency care; stabilizes patients and accompanies them to medical facilities; provides guidance and supervision to subordinates.
