### WHO MAY APPLY:

Must be a current member of the LA National Guard within the grade(s) of E4 and E6 and a current member of 62nd WMD-CST.

**AREA OF CONSIDERATION:** This position is open to the grades of: E4 to E6. Individual selected will receive an AGR Tour with the Louisiana National Guard. In order to be considered for this position's applicants must meet minimum qualifications as outlined on this announcement.

**INSTRUCTIONS FOR APPLYING:** All documents will be uploaded to FTSMCS no later than 2300 as one PDF in the order listed on the checklist. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position by the hiring agency.**

### 1. AGR APPLICATION

### MINIMUM APPOINTMENT REQUIREMENTS:

All enlisted jobs will be staffed in accordance with LAARNG AGR Enlisted Career Management Policy dated 1 December 2023.

1. Must have or be able to obtain the following minimum training within one year of hire:
2. 74D MOS, 6 weeks. Non- MOSQ: Must have ASVAB ST Score of 100 to be considered for reclassification into 74D MOS.
3. Civil Support Skills Course, 9 weeks.
4. Advanced Diagnostics Techniques Level 1, 1 week.
5. Survey Equipment Capabilities Course, 1 week.
6. IED Awareness, 1 week.
7. Chemical Warfare Agent/Biological Warfare Agent Laboratory Course, 1 week.
8. Emerging Threats, 1 week.
9. Applied Radiological Response Tech 1, Distance Learning.
10. HAZMAT Awareness, Distance Learning.
11. Must be able to be on one hour recall, 24 hours a day, seven days a week, unless on an approved leave status.
12. Must be able to receive required immunizations, to include Small Pox and Anthrax.
13. Must be able to pass CST performance test.
14. Must be able to pass an OSHA physical.
15. Incident Command Structure 100, 200, 700, 800. (Distance learning)
16. Must have normal color vision.
17. Must not have a shaving profile. Must be able to meet all requirements and qualifications to perform duties as a Hazmat Technician IAW NFPA 472.

### ADDITIONAL JOB INFORMATION:

- All exception to Policy request must be processed through Chain of Command and submitted with your AGR application to the AGR Branch regardless of concurrence.
- LAARNG promotion policies apply together with maximum grade limitations for the position as designated by NGB and appropriate MTOE/TDA.
- Acceptance of tour is subject to personal interview, ACFT, and Army body fat standards upon notification of time and place. Necessary travel is at applicant's own expense.
- AGR applicants must hold a SECRET security Clearance.
- Initial hire applicants must be able to obtain SECRET security Clearance
- Any Soldier selected without having a valid security clearance will be placed on OTOT (One Time Occasional Tour) and will be afforded an opportunity to attain appropriate clearance required. Soldier will be terminated upon receiving notification of his/her inability to acquire mandatory clearance for AGR Full-Time Position.
- Direct combat probability code applies: No, male or female may apply
- Deployed Soldiers are encouraged to apply for jobs. Deployment will not be held against the Soldier during the hiring process.
- NON-AGR applicants who require civil conviction waivers (applicants who possess civil convictions) must have approved waiver requests prior to closing of the AGR Tour Announcement that the Soldier is applying for. Any pending convictions should be annotated on the NGB 34-1 in Section V. Omitting any pertinent information that could effect becoming fully qualified is grounds for termination.
- NON-AGR Soldiers must meet eligibility requirements and qualifications for initial entry (3 year) in the AGR program IAW AR 135-18, Table 2-1 and NGR 600-5, Chapter 2-2. Applicants must be medically and physically qualified for Active Duty IAW AR 40-501, Chapter 3 and AR 600-9

- NON-AGR Soldiers must be able to complete their initial tour prior to reaching 18 years Active Federal Service or Retention Control Point.
  - Acceptance to a position of higher grade, SM will incur a service obligation in accordance with AR 600-8-19 upon promotion.

**BRIEF JOB DESCRIPTION:**

The CBRN NCO job requires utilizing state of the art CBRN detection equipment and conducting sample collection at an incident site (hot zone). CBRN NCO has knowledge of hazardous materials handling procedures and requirements. CNRN NCO executes chain of custody procedures per Department of Justice guidelines and unit Standard Operating Guidelines. CBRN NCO initiates set up and operation of assigned equipment for CBRN, toxic industrial chemical (TIC), toxic industrial materials (TIM) detection, identification, survey and sample collection. CBRN NCO performs all downrange operational tasks wearing appropriate level of PPE. Correctly marks contaminated areas for follow on support. Employs hand-held CBRN detection and identification equipment to detect CBRN contamination and obtains samples for medical or scientific analysis; responsible for the rescue and delivery of any injured team members to the decontamination line for appropriate treatment. Has a thorough knowledge of the CSTs decontamination procedures to include setup and operation of decontamination line. Has a thorough knowledge of the usage of appropriate antidote administration and safe patient extraction, crime scene/evidence preservation techniques, and participates in and monitors chain of custody (sample transfer) procedure. Understands hazards, wind direction and speed, safety precautions, types of tests to be performed, and turnback criteria. Uses appropriate guidelines to recommend the appropriate respiratory protection for team members. CBRN NCO will maintain NFPA Hazardous Materials Technician 472 certifications. Maintains Confined Space and Ropes certifications. Uses an execution checklist to monitor survey team detection, identification, and sample collection in the hot zone or contaminated area. In the absence of the CBRN NCO Staff Sergeant, OML selectee may have to perform as the CBRN NCO Staff Sergeant. Responds immediately to an incident site to Identify, Assess, Assist, Advise the Incident Commander to meet his/her objectives in a highly hazardous threat. You will be on called 24 hours a day 7 days a week subject to recall back to the CST ready building.
